A non-refundable deposit of \$1,000.00 is due on or before May 1, 2009.

The Curriculum, Technology, Field Trip, and Parent Association fees of \$685 will be billed and due on May 1, 2009.

No invoices are mailed. A \$25.00 late fee will be assessed for tuition not received by the 1st of the month.

Tuition express auto pay for checking, savings or credit card is available for any payment plan.

6. TERMS AND CONDITIONS:

(a) Amounts paid as a registration fee will not be accepted as such if a balance exists in a student's account. In such a case, the amount will be applied to the balance.

(b) After May 1, 2009, the obligation of the parent/guardian to pay the charges for the full academic year is unconditional and no portion of such charges outstanding will be refunded or cancelled notwithstanding the subsequent absence, withdrawal, or dismissal of the above student from the School.

(c) The total tuition fee includes costs such as tuition, meals, common activity fees, curriculum fee, technology fee, student field trip fee but does not include all other activities the student participates in which may require a charge.

(d) If the parent/guardian defaults on any payment or other obligation under this contract, the School reserves the right to refuse to admit or re-admit the student to class. If parent/guardian fails to pay any installment when due, the School reserves the right to declare all amounts immediately due and owing. In addition, a late fee charge of \$25.00 will be added to the outstanding balance in default. In the event this contract is placed with or collected by or through an attorney at law, parent/guardian agrees to pay 15% attorneys' fees and 18% APR on any outstanding balance in default.

7. In signing this enrollment contract for the 2009-2010 school year, the undersigned parent/guardian agrees to accept and abide by the rules, regulations, policies and standards of McGinnis Woods Country Day School. This contract supersedes the withdrawal policy as written in the Preschool Parent Handbook and application.
