6. TERMS AND CONDITIONS:

- (a) Amounts paid as a registration fee will not be accepted as such if a balance exists in a student's account. In such a case, the amount will be applied to the balance.
- (b) After May 1, 2021, the obligation of the parents/guardians to pay the charges for the full academic year is unconditional and no portion of such charges outstanding will be refunded or cancelled notwithstanding the subsequent absence, withdrawal, or dismissal of the above student from the School.
- (c) The total tuition fee includes costs such as tuition, basic meal plan, common activity fees, Annual Fund, curriculum fee, technology fee, student field trip fee but does not include all other activities the student participates in which may require a charge.
- (d) If the parents/guardians default on any payment or other obligation under this contract, the School reserves the right to refuse to admit or re-admit the student to class. If parents/guardians fail to pay any installment when due, the School reserves the right to declare all amounts immediately due and owing. In addition, a late fee charge of \$25.00 will be added to the outstanding balance in default. In the event this contract is placed with or collected by or through an attorney at law, parent/guardian agrees to pay the greater of \$1500 or 20% of the outstanding balance for attorneys' fees and 18% APR on the balance in default.

7. In signing this enrollment contract for the 2021-2022 school year, the undersigned parents/guardians agree to accept and abide by the rules, regulations, policies and standards of McGinnis Woods Country Day School. This contract supersedes all other withdrawal policies.
